## CAMP POLICIES, PROCEDURES AND CAMPER RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

In consideration for my dog being permitted to be a client "Camper" at a Camp Bow Wow franchise store (herein after "CBW" or "Camp") for day or overnight boarding, I make the following representations and agree to all of the following policies, procedures, terms and conditions:

1. CAMPER REQUIREMENTS. My Camper meets the following Camper requirements he/she: has successfully completed the Canine Camper Behavioral Interview; is four (4) months of age or older; he/she is spayed or neutered (if over six (6) months of age); is current on his/her Rabies, Distemper and Bordetella vaccinations; is in good general health and free of ticks and fleas; is not aggressive or protective of toys; meets all other municipal or state licensure and other requirements; is attending Camp with a quick release collar that contains an identification tag bearing the Camper's name and guardian or owner's current contact information. I have completed the Camper Application and have provided CBW with a current and valid credit card number. My Camper will enter and exit the CBW facility with a leash.
2. CAMPER FOOD. I understand that my Camper will not be fed lunch. If I want my Camper to eat lunch, I must bring a container marked with my Camper's name and feeding instructions. CBW will provide overnight Campers with food in accordance with the instructions provided in the Camper Application.

3. **CAMPER CAM, PHOTOS AND VIDEO RELEASE.** To watch my Camper having a dog gone good time at Camp, log onto [www.campbowwowusa.com](http://www.campbowwowusa.com) and click the Camper Cam button. I agree to allow any Camp Bow Wow franchise location, its owners, employees, officers, directors and agents and D.O.G. Development LLC, its owners, franchisees, employees, officers, directors and agents (hereinafter "D.O.G.") to use my Camper's name and any images or likeness of my Camper taken while he/she is a Camper at Camp, in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials. I agree that this provision shall be binding on me and all of my successors, heirs, legal representatives and assigns.
4. **PERSONAL PROPERTY.** I agree that CBW and D.O.G. shall not be responsible or liable for any lost, stolen or damaged personal property belonging either to me or my Camper. I also understand and agree that my Camper's collar may be removed in the play area to prevent injury to any dog. If my Camper causes any damage to the CBW facilities or equipment, I agree to be fully responsible for the full cost of any repair or replacement.
5. **CAMPER FEES.** I agree to pay for all camp fees, services and products with the credit card number I have provided in the Camper Application, or by cash or check at the time I pick up my Camper after each visit to Camp Bow Wow. I give my express permission for CBW and D.O.G. to charge any of the credit card numbers I provided on the Camper Application for any unpaid camp fees, services or products. I further agree to pay the cost of any check or debit charges returned or challenges for to any reason.
6. **CANCELLATION POLICY.** I understand that I will be charged for a full day of day camp, if I fail to cancel my day camp reservation twenty four (24) hours in advance. I further understand that I will be charged for a full day of boarding, if I fail to cancel my boarding reservation at least forty eight (48) hours in advance; or, if my reservation is within three days of a nationally recognized holiday, my reservation must be cancelled within seventy two (72) hours. If I fail to cancel a reservation for a boarding, I understand that I will be charged a no-show fee equal to two (2) nights of boarding.
7. **REFUNDS.** CBW's refund policy is available upon request.
8. **AGGRESSIVE DOGS.** My Camper is not aggressive. Although CBW loves all dogs, I understand that aggressive dogs are not permitted to attend CBW's Campers and that if my Camper acts aggressively or exhibits unacceptable behavior he/she may be separated from the other Campers. CBW will use reasonable efforts to consult Camper parents about aggression and ways to address it, however aggressive dogs may be asked not to return to Camp Bow Wow. Such determinations shall be made at the sole discretion of CBW or D.O.G.
9. **ABANDONED DOGS.** CBW is a place where all dogs loved, can romp and play. No Camper may be abandoned at Camp Bow Wow. I agree that I will not neglect to pick up my Camper from Camp by the time he/she is scheduled to leave without providing notification. Any Camper that is left at CBW without any contact, instruction or notification from me, of the ability, willingness or plans to pick him/her up by myself or my personal representative or agent, will be considered abandoned upon the seventh day of such notification failure. I understand that if I abandon my Camper at Camp Bow Wow, CBW will, by default, become the legal owner and guardian of the Camper. CBW will, in its sole discretion, determine whether to try to rehome and adopt the Camper from the CBW location at which he/she was abandoned or will relinquish the Camper to an unrelated shelter of its choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT CAMP BOW WOW, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST CBW OR D.O.G. AS PROVIDED FOR BELOW.
10. **DUTY TO DISCLOSE.** I have disclosed and shall continue to disclose on an on going basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my Camper's ability to participate in play time or otherwise attend CBW's Campers.
11. **CAMP PARTICIPATION.** I understand participation in play time is at the sole discretion of CBW and that Campers may be separated from other Campers or asked to leave for any reason in CBW's sole discretion.
12. **ACCEPTANCE AND ACKNOWLEDGEMENT OF CAMP PARTICIPATION RISK.** I FULLY UNDERSTAND THAT: (a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN DOGS AND OTHER DOGS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR DOG; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY, "RISKS"). I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY OR MY CAMPER'S PARTICIPATION IN CAMP, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF MY DOG. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLA (KENNEL COUGH) OR ANY OTHER FORM OF CONTAGIOUS ILLNESS.
13. **VETERINARIAN LIABILITY AND CARE.** I agree to allow CBW or D.O.G. to obtain medical treatment for my Camper, if, in its sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my Camper may need medical treatment. If a Camper passes away at Camp, it will be brought to its or the nearest veterinarian. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT, AND FOR THE COST OF ANY TRANSPORTATION FOR THE PURPOSES OF SUCH TREATMENT, PROVIDED TO MY CAMPER.
14. **WAIVER, RELEASE AND INDEMNIFICATION.** I HEREBY EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND AND COVENANT NOT TO USE CBW OR D.O.G., and their invitees, sponsors, advertisers, owners, officers, directors, employees, volunteers, invitees, agents, lessors, and any parties owning, controlling or having any interest in the property at which the Event is taking place, and all other representatives or agents (the "Releasees") from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, EXPENSES OR DEMANDS (including reasonable attorney's fees) OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releasees, including negligence, and (ii) my or my Camper's participation in activities at Camp Bow Wow, or otherwise. I FURTHER AGREE TO INDEMNIFY, SAVE AND HOLD HARMLESS the Releasees from any claims, litigation, actions, suits, damages, costs, attorney's fees, losses or injuries as the result of any such claim. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE CBW AND D.O.G. FROM ANY DUTY TO PROTECT ME OR MY DOG(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF CBW AND D.O.G. CHOOSE TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED CBW AND D.O.G. FROM ANY DUTY TO PROTECT ME OR MY DOG(S).

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS "CAMP POLICIES, PROCEDURES AND CAMPER RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" (THE "AGREEMENT") AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THAT THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT.
